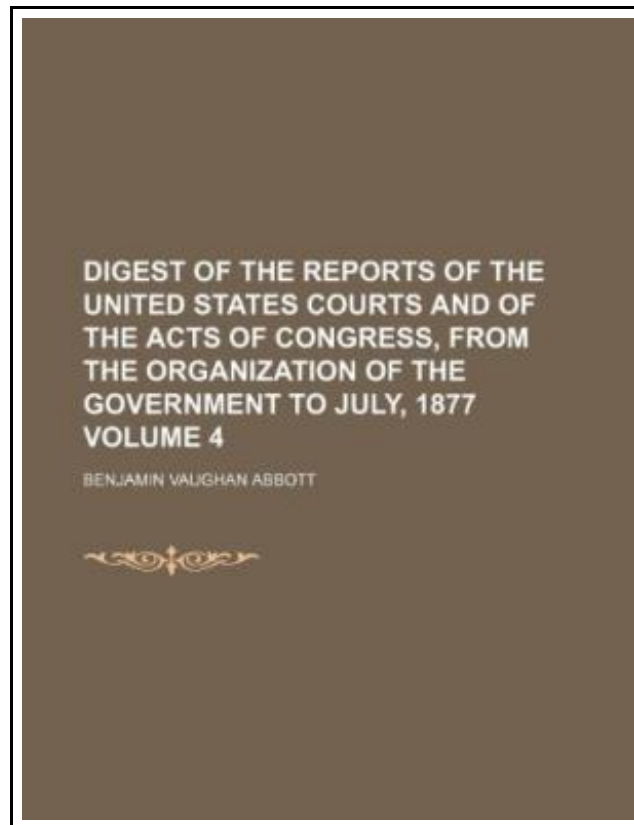



To entitle a party to review the refusal of the judge to instruct the jury as asked, he must state the precise point which he wishes decided; and if the decision is against him. he must except to it, specifically.
